

**BARAMUNDI SOFTWARE USA, INC.**  
**BEERSTEIN HOLDING CONTEST**  
**OFFICIAL RULES**

**1. NO PURCHASE NECESSARY TO ENTER OR WIN.**

2. **HOW TO ENTER:** The Contest begins on September 5<sup>th</sup>, 2023 at or about 5 pm Central Daylight Savings Time (“CDT”) and ends on September 7<sup>th</sup>, 2023 at 3 pm CDT (the “Contest Period”). You may return to our booth to enter again; however, no more than one entry per day per person is permitted. Between 09/05/2023 and 09/07/2023 entrants will compete to hold one (1) liter stein filled to the brim with liquid in one (1) liter cans and held by a straight ninety degree (90°) arm in front of entrant, parallel to the floor with elbows locked. Once entrant’s elbow bends or spills/drops the stein, the time will be stopped, and the Contest ends for this entrant. Only steins provided by Sponsor specifically for the Contest can be used for the Contest. Entrants who drink out of the Sponsor supplied stein will be disqualified. No other stein may be substituted for the stein that Sponsor provides contestants. Each round of stein hoisting will consist of approximately one (1\_) to six \_\_\_\_\_ (\_6\_) participants. Entry is not limited. A Sponsor representative will record the time of every entrant holding his or her stein. From all the completed rounds each day, a daily winner with the longest stein hoisting time will be selected as the winner of the day (“Winner of the Day”). In the event there is a tie between two (2) or more entrants, the lot decides the winner for the day. From all Winners of the Day, the entrant with the longest time recorded will be deemed as the grand prize winner. In the event there is a tie between two (2) or more Winners of the Day, the lot will decide the winner of the grand prize. Multiple entrants are permitted to share the same address.

3. **ELIGIBILITY:** Open to participants of the “SpiceWorld 2023, 21 years of age and older as of September 5<sup>th</sup>, 2023, except for employees of BARAMUNDI SOFTWARE USA, INC. (“**Sponsor**”), ITS affiliates, subsidiaries, and agencies (collectively “**Promotion Parties**”), and members of their immediate family or persons living in the same household. Void where prohibited.

4. **CONTEST:** The contestant who can hold their stein with proper form (as described in the rules in Section 2 above, the “Contest Rules”) for the longest without being disqualified by the judge(s) will be considered the winner. All income taxes resulting from acceptance of prize are the responsibility of winner. By entering this contest, the Contestant accepts and agrees to these Official Rules and the decisions of the judges, which shall be final in all matters. Acceptance of a prize also constitutes permission to the Promotion Parties to use the winner’s name, and likeness and biographical information for marketing purposes, including social media posts, without further compensation or right of approval, unless prohibited by law. 8. **GENERAL TERMS.** Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Contest, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Contest, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law.

9. **CHOICE OF LAW AND FORUM:** Contestant agrees that all matters arising out of or relating to this contest these Official Rules are governed by, and construed in accordance

with, the laws of the State of Texas, without giving effect to any of its conflict of laws provisions thereof. Contestant further agrees that any legal suit, action, or proceeding arising out of or relating to this contestand these Official Rules shall be brought exclusively in the applicable federal or state courts located in Austin, Texas.
